OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. 1. NO PURCHASE NECESSARY. The Surly Brewing Furious 48 Sweepstakes (“**Sweepstakes**”) sponsored by Surly (“**Sponsor**”) begins October 14, 2019 at 12:00:00 AM Central Time (“**CT**”) and ends December 22, 2019 at 11:59:59 PM CT (“**Sweepstakes Period**”). The Sponsor’s computer, or that of its designee, runs the official clock for the Sweepstakes and will solely determine the time by which an entry is received.

2. ELIGIBILITY: This Sweepstakes is open only to legal residents of Minnesota, Wisconsin, Iowa, South Dakota, North Dakota, Colorado, Missouri & Illinois who are twenty-one (21) years of age or older at the time of entry (“**Entrant**”). Void where prohibited or restricted by law. Employees of Sponsor, any advertising or promotional agencies involved in the promotion, state alcohol beverage commissions, alcoholic beverage manufacturers, distributors, wholesalers and license retailers, and their respective parent companies, subsidiaries, affiliates, and their immediate family members (spouse, parent, sibling, and children, regardless of where they reside) or members of the same household (whether they are related or not) of any of the foregoing are NOT eligible to participate. 3. HOW TO ENTER: There are four (4) methods of entry:

Method #1: Online Form Entry:

Beginning at 12:00:00 AM CT on October 14, 2019 visit www.surlybrewing.com/Furious48, complete all required information, including name, address, email, phone number and date of birth on the Sweepstakes entry page, and follow the on-screen instructions to submit your entry. Entries are deemed made by the authorized account holder of the email address submitted at the time of entry. The “**authorized account holder**” is defined as the natural person who is assigned to an email address by an Internet Access Provider, Online Service Provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address. All online entries must be received by 11:59:59 PM CT on December 22, 2019.

Method #2: Online Social Entry:

To enter the Sweepstakes via social media using your personal Facebook, Twitter or Instagram account, you must follow Surly Brewing and publish a post using the hashtag “FURIOUS48” during the Sweepstakes Period. Limit of one contest registration per week, per person. Week begins on Mondays. ReTweets will not accrue entries in this Sweepstakes. Posts where the hashtag is included in a comment to the original post will not be deemed entries.

To participate and enter this Sweepstakes via social media, individuals will need a mobile device (e.g., mobile phone or tablet) that can access the Internet and uses either the Apple or Android platform. Additionally, individuals will need to download the Facebook, Twitter or Instagram applications from their mobile device’s app store and sign-up for an account. By submitting your information and creating an account entrants will be required to agree to the Facebook, Twitter or Instagram terms of service and privacy policy. Method #3: Untappd Check-In:

Method #4: Text Entry:

To enter the Sweepstakes via text message, text the keyword “FURIOUS48” to 55678 (“**Short Code**”) during the Sweepstakes Period.

Wireless Phone Users - Additional Terms: You may receive one (1) or more text messages in response to your text entry, including a message confirming your entry, and legal disclaimers from Sponsor. You may opt-out of receiving the promotional text messages from Sponsor at any time by sending a reply text message with the word “STOP”. Sponsor is not responsible for: (i) electronic, wireless or digital transmissions or any entries that are lost, late, stolen, incomplete, illegible, damaged, garbled, destroyed, misdirected, or not received by Sponsor or its agents for any reason; (ii) any problems or technical malfunctions, errors, omissions, interruptions, deletions, defects, delays in operation or transmission, communication failures or human error that may occur in the transmission, receipt or processing of entries; (iii) destruction of or unauthorized access to, or alteration of, entries; (iv) failed or unavailable hardware, network, software, SMS text or telephone transmissions; (v) damage to Entrant's or any person's computer or wireless device or its contents; (vi) causes beyond Sponsor's reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of this Sweepstakes; (vii) any entries submitted in a manner that is not expressly allowed under these Official Rules; (viii) incorrect or inaccurate entry information whether caused by entrants or by any of the equipment or programming associated with or utilized in the Sweepstakes; (ix) any typographical or other error in the printing or advertising of the offer, administration or execution of the Sweepstakes, or in the announcement of prizes or prize winner; (x) malfunctions or interference resulting from illicit, malicious or injurious code (including but not limited to viruses, worms and denial of service attacks); or (xi) cheating or fraud by any participant. Each potential winner will also be required to sign and return an Affidavit of Eligibility and W-9 and provide a copy of his/her valid driver's license, which must all be received by Sponsor within fourteen (14) days of the date notice or attempted notice is sent, in order to claim his/her prize.
